# INVITATION TO TENDER

### 1.0 PREAMBLE

The Ekiti State Water and Sewerage Company Limited (EKWSC) in its bid to implement the Sustainable Urban and Rural Water Supply, Sanitation and Hygiene Programme (SURWASH) is seeking to engage interested Bidders in Rehabilitation of Ijan Booster Station & stabilization of Ado-Ijan trunk mains *in Ekiti State*.

### 2.0 SCOPE OF WORK:

Rehabilitation of Ijan Booster Station and Stabilization of Ado-Ijan Trunk mains.

#### 3.0 MANDATORY REQUIREMENTS

Interested Contractors are to submit along with their bids the following documents:

- a. Evidence of Registration with the Corporate Affairs Commission (CAC);
- b. Current Tax Clearance Certificate of at least TWO Directors or Proprietors;
- c. Evidence of Registration with the Ekiti State Bureau of Public Procurement;
- d. Evidence of Registration with EKWSC
- e. Evidence of Registration with Nigeria Social Insurance Trust Fund
- f. Company's Audited Account for the last 3 years;
- g. Evidence of financial capability from reputable Bank(s);
- h. Company's profile, organogram and resume of relevant key technical staff, including individual attestation of availability. Include copies of professional certificates with seal and endorsement;
- i. Verifiable evidence of similar projects previously undertaken, including letters of awards and Completion Certificates within the past five (5) years; indicate the financial value of these similar projects, which must be at least 50% of the value of the bidders current bid price (if any):
- j. Description and list of relevant equipment owned by contractor, include proof of ownership or lease or license over the equipment (if any);
- k. Evidence of payment of Tender Fee;
- 1. Instruction to bidders and Bid Submission Sheet (which are included in the tender documents issued by EKWSC) must be fully signed and enclosed in the bids to be submitted;
- m. Evidence of Previous projects handled before must be attached and submitted to Ekiti Water and Sewerage Company Limited;
- n. Evidence of registration with Ekiti State Water and Sanitation Regulatory Agency (EK-WASRA);
- o. Interested bidders to submit original Bid security from reputable bank with a value of 1.5% of the contract sum valid for a period minimum of 90 days.
